Molly Scott Cato

I am putting myself forward for the honour of becoming vice-chair of the European Movement. I firmly believe that EM is the organisation that will mobilise public opinion and coordinate a successful campaign for us to rejoin the EU and I am committing my time to making that a reality.

For those who don't know me, I was a Green MEP representing South West England and Gibraltar from 2014 to 2020. I was very actively involved in the 2016 referendum campaign and then fought Brexit tooth and nail until the bitter end. As an economist I also began the campaign to have the Brexit impact studies made public and helped to expose the fraud and deceit that typified the campaigns of the Brexiteers.

The European Movement is a campaigning organisation but we are also an organisation that needs to be strategic and thoughtful. This is a long game and we need to build our credibility and our strength. I was glad to be part of the committee that has appointed our high-level communications staff and am looking forward to working with them and our campaigns staff to build up these parts of our work.

Our strength is in our members and our branches. The disappointment of missing out on the People's Vote – by a whisker – has led to some demoralisation but it's time now to capitalise on the manifest failings of Brexit Reality to share resources, messages and campaign ideas to energise the remobilisation that will lead to our rejoining the EU.

Another key priority for me would be to develop a credible pathway back to EU membership. There are a number of logical steps to remain to a stronger relationship but we have to be clear about what the legal route looks like and strategic about the order of the steps we should take. We need a concrete plan that can then inform our strategic communications and our grassroots campaigning.

And a personal commitment is the need to build our Movement into a truly representative movement, one whose members look like the people of the UK who will make the decision to rejoin. We need to think about expanding beyond our own cultural and ethnic circles and use our communications strategically to achieve this. I was delighted to accept Andrew Adonis's request that I undertake a diversity review of the Movement. The constitutional amendments we proposed have been adopted but we still need to follow through on further recommendations for change, something I would ensure if elected as vice chair.

Thirdly I think we have a role in keeping strong diplomatic relationships open with with EU capitals. The government has been burning bridges but I think that, as a Movement, we have the capacity, the skills and the people to perform an important role here in the best interests of the UK.

I see huge opportunities for the European Movement so long as we become genuinely inclusive and unified. I hope you will support me and that together we fulfil our potential.

Nick Hopkinson

When David Cameron gave his January 2013 Blomberg speech, I knew we would lose any in/out referendum. We had 40 years of fake news. Pro-European forces were weak. The European Movement (EM) had barely 4% of our current members. Yet we valiant 500 resolved to strengthen it. Today the EM remains our best vehicle to rejoin the EU.

UK membership of the EU is in our national interest. We are more prosperous, equal, safer and greener in the EU. While Director of the Foreign Office policy forum for almost 25 years, I helped the UK stand tall championing the Single Market and enlargement. Since as founding chair of the first 4 Europe group, London4Europe (L4E), I pioneered engagement programmes with the Sikh and Pakistani communities, gave 50 talks and edited and wrote hundreds of blogs https://www.london4europe.co.uk/if_we_don_t_join_up_we_ll_never_rejoin.

As Branches Forum Chair from 2016-19, I was instrumental in bringing in 90 local groups into the EM family. Sadly, in the past two years, EM officers have attracted few new local groups.

We need to learn the lessons of the People's Vote debacle at Millbank. We need to focus on strengthening the one organisation which has a chance of making a real impact. But we need to embrace other groups and respect their independence. We need discipline and strategy, not isolated actions. We need teamwork, good governance and a movement for members and branches, not just a movement for the politicians. We also need to rise above party tribal loyalties – we shall never win if we marginalise 6 million Conservative pro-Europeans. We need to build the EM into a force that will win for us all.

The EM needs a Vice-Chair dedicated to building up the EM rather than organisations outside it. Our renewed emphasis on diversity is welcome, but we also need to respect rules, processes and codes of conduct to attract the mass movement we want. If elected, I shall focus on developing these areas. Strategies and targets need to be transparent and regularly reviewed against plan. The new National Council needs orientation briefs to empower them. We need coherent national structures, not an uncoordinated patchwork of groups with different brands communicating different messages.

Richard Wilson

I have been proud to hold the post of Vice Chair of EMUK for the past two years – a period of unprecedented change and growth for our organisation.

I see my role as being the voice of ordinary members and affiliated groups at the highest level of our movement. I am full of respect and admiration for the effort and sacrifices that our grassroots campaigners have made. I want to see this ethos of friendship, respect and inclusion replicated up to the highest levels of our movement.

I strongly support our strategy of "Step by Step to Rejoin". It is vital that EM spreads the message that "Brexit Isn't Working" and that the positive solution is for the UK to move into much closer alignment with our European neighbours, with whom we share values, economic interests and a yearning for peace and cooperation over rivalry and conflict.

Sajjad Karim

The 9th November 1989 changed my life.

As, from my living room in Lancashire, I watched people tear down the Berlin Wall with their bare hands, I began to realise that a better world was available. One where identity and arbitrary borders built on historic division and hate were no longer reasons to limit potential.

For me, the European Union, with its fundamental role as a peace keeper and Single Market, provided the basis for that world I wanted to see. Shared values, development, economic growth, innovation and so much more allowed us to aim so much higher than ever before.

Anthony John Bridge

I believe that a united Europe, one joined by shared values, is essential to our collective future, and that I can help the Council by providing a fierce voice for that unity.

Chris Stern

I believe that the issue of working more closely with the EU as an organisation and with all the member states with a view initially to aligning the UK with the Single Market, then joining it and in due course the EU is the most important issue in British politics today.

It is important because:

1 There is a very strong need for Europe to speak with as much strength as it can muster and to act as a counterpoise to the power of the Russian Federation, China and the USA.

2 The economy of the UK is already declining relative to that of the EU - about 5% or 6% since 2016 - we need to at least be in the Single Market to redress that difference.

3 We need to be part of the EU to influence its international policies so that the European voice is heard - the British voice will continue to decline - we are too small.

4 We need the free movement of people to enable our young people to live a life with full opportunity to work internationally.

In summary, we should look to a staged re-entry to full membership of the EU.

Peter Corkill

My awakening to the EU came when, aged 19, I decided to learn Spanish by moving to Spain. Freedom of movement made this easy, and it changed the course of my life. I want UK citizens to be able to enjoy again the freedoms and opportunities I had, and the increased prosperity we will have when we rejoin.

I have been involved in voluntary groups all my life. I set up an Oxfam society at university, I was involved in the Anglo-Bolivian Society for many years, including as Chair (our events included talks by government ministers, and UK diplomats). My first job was as National Organiser of the Conservative Group for Europe, under John Gummer, and then Leon Brittan.

I have been Chair of Warwick District 4 Europe since April 2018. On the National Council I would I stress the need for the EM to be outward looking. We need to be focussed on our core mission and to campaign to change public opinion. I believe the EM needs to provide branches with practical and financial help.

People of all political parties and none are pro-European, we need to work together to achieve our re-entry into the European Union.

Saffron Rainey

I joined the European Movement because I began to help out at the regular Brexitometer that was a regular part of life on the streets of Oswestry, N Shropshire. We felt a great connection to the many people who hoped for a People's Vote and enjoyed many excellent conversation with committed Leavers. I am passionate about promoting healthy discourse where objectivity and evidence can be allowed to inform and guide the debate.

Since May of 2020 I have been the chair of European Movement Shropshire (EMS), which is a countywide affiliate/branch represented at the committee level by people from all the five Shropshire Constituencies. As the branch chair I've set up the EMS website, I am the editor of a monthly newsletter and have organised online public events. Last month we took to the streets with the N Shropshire Brexitometer to coincide with a local food festival to highlight the stresses being felt across the food production sector. I was an early Erasmus Student (Valladolid, Spain 1993) and believe we should be lobbying for manifesto commitments by the opposition parties to

return to the Erasmus + scheme. Shropshire and Herefordshire 4 EU have been working in collaboration at a pilot program to highlight the loss of Erasmus+.

I am urban economist and feel we as a movement could do more to highlight the economic impact on places that the blind commitment to a hard Brexit by Johnsons' Tory's has had. The impact on the West Midlands, the NW and NE is particularly acute as many SME's are part of Just-in-TIme production systems that link manufacturers across the continent, and are now hampered by increased bureaucracy, increases in transport costs and the need for greater inventory, all impact the viability of these firms.

The journey back to EU membership will be long and it will be achieved by incremental steps of rejoining the institutions and practices that have bonded us for the past 40 years. There is a growing unease to our new status as outsiders. I was speaking to a friend at the weekend who teaches economics at a local school. He used this example to his class at to what they have lost. "Next year on your summer holiday before going to university you could be in Ibiza, you are having a great time, someone offers you a holiday job for the season, before Brexit you could of stayed the summer in Spain, you can't now." He said this struct a cord with his whole class. This is where we need to build a consensus from. I see our role and creating a groundswell of demands for our nation to be connected to the EU as a good neighbour not an adversary.

We need to be campaigning, and pushing the facts that Brexit is at the heart of so much that is not working in the country right now. As an organisation EM are uniquely placed to ensure that the 'Brexit is not Working' message is heard.

Simon Apana Agey

Unity is strength. The Anglo-Saxon values are part and parcel of the EU fabric. Brexit is an illusion.

Ted Anderson

As a proud European, I have always been positive about UK participation within European Organisations – both Council of Europe and European Union. Which have positively shaped our recent history.
